The meeting observed a minute's silence in their memory.

7. Branch Matters

a)Transfer of towers to N Bucks Branch

The following resolution from the committee was considered and put to the vote: "Following representations made at the 2009 AGM by the North Bucks branch and a unanimous petition from the ringers at Padbury and Hillesden, the Central Bucks Branch of the ODG resolves to recommend to the ODG General Committee that Padbury and Hillesden be transferred from the remit of the Central Bucks Branch to the North Bucks Branch" Carried nem con. Note: This will take effect from the date of the ODG General Committee at which it is accepted. b) CBB Website: Hal Drysdale reported on the progress on the new site www.bellringing.biz/cbb This has recently gone live and will shortly be linked from the ODG website as the official site. Ryan Noble is assisting with the site.

c) Newsletter: Jan appealed for a volunteer to take over the newsletter and Diana Slevin offered to take it into the secretary's duties. In order to expedite delivery and avoid postal charges, the newsletter will be distributed by email where possible and posted on the website, but print copies will also continue be sent to those not able to have access via the internet. A schedule of dates will be provided starting with an immediate edition that will include a report on the AGM.

d) Other communications: the circulation system for items such as Odd Bob will be re-examined

e) Recruitment: some ideas for recruitment were discussed. Diana Slevin reported that the committee had been pleased with the response at the events where a mini ring was present e.g. at the Deanery stand at the Bucks Show but had decided not to book one for events unless a third party was bearing the cost. In this case we could offer to run it on the day. Ongoing contacts with Bucks CC might result in a ringing stand possibly with a mini ring at some events in 2010. Alan Marchbank recommended that contact be made with the ODG Education Committee which might be able to offer some forms of assistance. It was suggested that we pool ideas from various

towers to develop a recruitment strategy. 8. Branch programme.

a)Practices: Branch, Progress and Advanced - provisional list of activities was available. It was reported that the idea of varying the timing of the regular branch practices would be tried to see if it proved popular with members. E.g. the Mursley practice, rescheduled for April10th will be held in the morning 10-12am

b)Striking Competitions

The June 6 Bell striking competition is due to be held on June 12th at East Claydon (tbc) and Chiltern Branch are due to host the Orchard Cup 3rd Sat in October. Members were urged to encourage more teams to enter as turnout had been disappointing in 2009..

c)Branch Outings

Hal Drysdale reported that he was planning another family based outing this time centred on the GWR steam railway near Cheltenham for June 26th.

Jan Robinson offered to organise the traditional outing on September 11th and invited suggestions for areas to go to e.g. David Body suggested a trip to North London similar to the previous Wing outing which had used an historic bus.

d) Christmas Dinner

Ideas were invited for a pub able to cope with a large party probably in January 2011, preferably in the Bierton area.

e)Guild Events

The AGM is scheduled for May 15th at a Newbury Branch tower. Alan Marchbank reminded the meeting of the call for special ringing events to mark the 100th anniversary of the death of the Rev Robinson, the first Master of the guild. Anything taking place should be reported to the current Master.

9. Any Other Business

a) Vote of thanks: Ailsa Knightley proposed a vote of thanks be recorded to Heather Dobson and Hal Drysdale for their work helping towers such as hers ie Stewkley, to progress ringers.

b) The Branch 'Swindle': for various reasons this Branch Practice raffle had not been held at all practices in 2009. It was agreed that the outstanding monies from 2009 subscriptions be donated to the Bell Fund. Jane Vowles offered to help Phil Roberts run this in 2010.

c) Guild Bell Funds: it was reported that CBB's contributions to the Bell Fund over the last few years totalled less than the benefit received from it, and that in general CBB donated less than other branches. It was agreed to encourage towers to think of ways to raise more money for the funds and publish a list of suggestions. One idea for all members was to offer them the opportunity to add a sum to their annual subscription. Jane Vowles reported that the collection at this AGM and half the money contributed for teas would be donated to the fund

d) Meeting thanks: from the Chair, Jan Robinson offered the meeting's thanks to all at Quainton for their hard work in enabling the AGM notably the Vicar Rev Phillip Mears, Organist June Hanson, Tower Captains Jane Vowles and Phil Roberts.
